# Privacy Policy for Naughty Coins

Last updated: July 29, 2023

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use some of Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

# Interpretation and Definitions

### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### **Definitions**

For the purposes of this Privacy Policy:

 Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.

- Application refers to Naughty Coins, the software program provided by the Company.
- Company (referred to as either "the Company", "We",
   "Us" or "Our" in this Agreement) refers to Naughty Coins.
- Country refers to: Bayern, Germany
- Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- Personal Data is any information that relates to an identified or identifiable individual.
- Service refers to the Application.
- Service Provider means any natural or legal person who
  processes the data on behalf of the Company. It refers to
  third-party companies or individuals employed by the
  Company to facilitate the Service, to provide the Service
  on behalf of the Company, to perform services related to
  the Service or to assist the Company in analyzing how the
  Service is used.
- Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).
- You means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as

applicable.

# Collecting and Using Your Personal Data

### **Types of Data Collected**

#### **Personal Data**

- Your email address, in case if you send the Company an email.

#### **Usage Data**

We might collect some usage data You willingly decide to send to the Company in the feedback email. The feedback email is pre-filled with a long number that we can translate into information regarding:

- Your premium membership
- the amount of currently remaining transactions for non premium users
- first app launch date timestamp
- number of logo taps
- budget count
- current budget envelope count
- current budget bank accounts count
- current budget transactions count
- current budget indicator rating
- selected currency
- starting day of the week
- currently selected app style

You can freely remove the pre-filled information in the feedback email. In that case the Company will not receive any data from You about the usage of the Service.

#### **Use of Your Personal Data**

The Company may use Your email address in order to reach out to You with the purpose of replying to Your email.

If You have sent a feedback email to the Company because of an issue you are experiencing, the Company might use the usage data You have sent in the email in order to conduct a better research and provide a better resolution of the issue.

We never share Your personal information, nor the usage data with anyone.

### Retention of Your Personal Data

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We

are legally obligated to retain this data for longer time periods.

# Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.

Your consent to this Privacy Policy followed by Your submission of such information represents Your agreement to that transfer.

The Company will take all steps reasonably necessary to ensure that Your data is treated securely and in accordance with this Privacy Policy and no transfer of Your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of Your data and other personal information.

#### **Delete Your Personal Data**

You have the right to delete or request that We assist in deleting the Personal Data that We have collected about You.

Please note, however, that We may need to retain certain information when we have a legal obligation or lawful basis to do so.

#### **Disclosure of Your Personal**

#### **Data**

#### **Business Transactions**

If the Company is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred. We will provide notice before Your Personal Data is transferred and becomes subject to a different Privacy Policy.

#### Law enforcement

Under certain circumstances, the Company may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

#### Other legal requirements

The Company may disclose Your Personal Data in the good faith belief that such action is necessary to:
